GENERAL SHOW RULES & REGULATIONS

1. **Entries close March 20, 2026.**
2. Open to registered participants ages 6 to 21 years old as of December 31, 2025. Participants ages 6 to 8 years old are only eligible to participate in the demonstrations. Non-refundable
3. Registration for the Stierwalt Demonstrations is \$100 plus GST per participant, which includes Friday and Saturday lunch tickets for the participant and one (1) parent.
Those wishing to participate in the show must register and attend all sessions for the seminar.
4. **Registration for the Hands-On Clinic will be an additional \$50 plus GST per participant. The Hands-On Clinic is only open to participants that are registered for the demonstrations. Hands-On Clinic is open for viewing by all registrants. *Limited spots available***
5. We encourage Club signs. Club Displays will be allowed but not compulsory. We request all areas including stalls, tack boxes, etc. be maintained in a neat and orderly manner.
6. Entries must be made in the name of the person exhibiting.
7. All animals:
 - must be halter broke
 - steers must be dehorned
 - must have approved RFID tags.
 - may be subjected to a veterinary inspection
 - must have neck ropes
8. All exhibitors are required to have a fully completed manifest accompany the animals being transported to and from the show as required by Saskatchewan Ministry of Agriculture.
9. Exhibitors are required to bring their own feed.
10. All exhibitors must register at the Saskatchewan Beef Expo Show Office at the indicated registration time.
11. It is the responsibility of the exhibitor to advise the Show Office of any cancellation of entries.
12. Exhibitors are encouraged to use a show harness for their numbers. Numbers will be allocated to exhibitors and must be worn in the show ring.
13. Participants in this competition will be provided with a program containing specific information on barn, show ring, wash rack regulations, special awards and other information.
14. Entrants and their exhibits shall come under the supervision and direction of the Saskatchewan Beef Expo Show Committee and shall observe all reasonable rules and regulations established by the Committee for the orderly conduct of the program.
15. Tampering with Livestock:
 - a) Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hooves or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
 - b) The use of drenching, mechanical pumping devices, or other abnormal methods to administer water or fluids to animals will not be permitted, except for veterinarian approved treatments for dehydration.
16. The Saskatchewan Beef Expo Show reserves the right to decide on any point not covered in the rules and regulations and to make such changes in the prize list as are deemed necessary and in the best interest of the Show.
17. Competitors and their exhibits shall enter the competitions at their own risk.

18. The Saskatoon Prairieland Park Corporation, its Directors, Committee Members, Management or Employees shall not be responsible in any way for any injury to any person or for any loss of or damage to any property belonging to the Licensee or Renter or such other person or persons contracting herein for the use of property or premises of Saskatoon Prairieland Park Corporation, their invitees, licensees, agents, contractors, sub-contractors, affiliates, employees or workmen, while such person or property is in or about the premises, or any roadways, platforms or corridors in connection therewith, including (without limiting the foregoing) any loss of or damage to any property caused by theft or breakage, or by steam, water, rain or snow which may leak into, issue or flow from any part of the premises or any adjacent or neighboring land or from the water, steam or drainage pipes or plumbing works thereof or from any other place or corridor or for any loss or damage caused by or attributable to the condition or arrangement of any electric or other wiring or for any other loss whatsoever arising out of the occupancy of the premises or any operations or activities conducted therein by such persons as aforesaid; and the Renter or Licensee and such other person or persons contracting herein for the use of property or premises of Saskatoon Prairieland Park Corporation covenants to indemnify the Saskatoon Prairieland Park Corporation, its Directors, Committee Members, Management or Employees against all loss, cost, claims, or demands in respect of any injuries, loss or damage referred to in this paragraph.
19. Any entrant or exhibitor may be required by the Saskatoon Prairieland Park Corporation to make a statutory declaration that the exhibits entered are shown in accordance with the rules and regulations governing the show. Should any exhibitor refuse to make such declaration on being requested, he or she will forfeit premiums awarded on the entry in doubt.
20. Any person who shall attempt to interfere with or influence the judge(s) while in the discharge of their duties, or shall at any time, on the premises of the Saskatoon Prairieland Park Corporation, use any contemptuous or abusive language to any judge, or within their hearing, in consequence of any award made by them, or any exhibitor refusing to accept any award made by a judge, shall forfeit their right to any premiums to which they might otherwise be entitled. Judges are particularly requested to report any breach of this rule.
21. Judges will award prizes only to deserving exhibits; where there is no competition, the judge shall decide whether the exhibit entered is entitled to the first or any other prize.
22. When respectfully requested to do so, the judges may give the reason for their decisions.
23. All entries will be submitted through the online form available on the website. The particulars called for on the entry form must be fully and correctly supplied and properly acknowledged by the exhibitor or their duly authorized agent.
24. Prize money will be presented at the Show Office.
25. Any entrant or exhibitor, by act of making entry, exhibiting or occupying any space on the Saskatoon Prairieland Park Corporation grounds, agrees to the rules and regulations printed herein.
26. We encourage parents to work with their children, not just do the work for them. Adults and parents must keep in mind that this is an educational opportunity for the participants of the show and therefore limited parental involvement is encouraged.
27. No dogs are permitted in the barn or arena at any time; we encourage you to leave your dog at home.
28. **Verbal abuse of Saskatchewan Beef Expo Showcase committee members and Prairieland staff will not be tolerated. All complaints are to be directed to Agriculture Manager. Prairieland Staff and committee members reserve the right to eject any person from the event at any time.**
29. The Saskatchewan Beef Expo Committee reserves the right to decide on any point not covered in the rules and regulations and to make such changes in the prize list as are deemed necessary and in the best interest of the Show.
30. The use of stereo systems in the barn must be kept at a level considerate to those stalled close to your stall.

SASKATCHEWAN BEEF EXPO DISCIPLINARY RULES & REGULATIONS

- ✦ **Anyone with any indication of having consumed alcohol or drugs will be expelled from the competition.**
- ✦ **NO SMOKING and NO ALCOHOL in stabling or show ring areas.**
- ✦ **Abusive language or undesirable actions will not be tolerated.**
- ✦ **Stall area must be kept clean at all times and must be clean when you leave, otherwise you will be billed for clean-up.**
- ✦ **Participants will be advised of any further regulations for the proper operation of the show.**

DISCIPLINARY ACTION

Any violation of the Saskatchewan Beef Expo program or regulations established by the Saskatchewan Beef Expo Committee shall automatically result in forfeiture of any prizes. The Committee may also refuse special privileges, send the junior competitor home and/or contact the parents.

Saskatoon Prairieland Park Corporation is pleased to present this program of special competitions and seminar that are designed to encourage the interest and participation of Saskatchewan youth in agriculture and rural life. *We gratefully acknowledge the co-operation and assistance of the numerous firms, organizations and individuals that helped make this program possible.* Open to registered 4-H Club Members and Junior Exhibitors who are 6 to 21 years of age as of December 31, 2025.

OBJECTIVE:

Young producers participate in activities designed to increase the development and understanding of husbandry, marketing and presentation of beef cattle.

RULES & GUIDELINES

1. Stierwalt demonstrations are open to all youth aged 6 to 21 as of December 31, 2025. Participants ages 6 to 8 years old are only eligible to participate in the demonstrations.
2. Registration close March 20, 2026.
3. Registration for the Stierwalt Demonstrations is \$100 plus GST per participant, which includes Friday and Saturday lunch tickets for the participant and one (1) parent (must declare at time of entry submission). Additional lunch tickets may be purchased.
4. **Registration for the Hands-On Clinic on Saturday will be an additional \$50 plus GST per participant. The Hands-On Clinic is only open to participants that are registered for the demonstrations. Hands-On Clinic is open for audit by all registrants.**
Limited spots available
5. Those wishing to participate in the show must register for and attend all the educational demonstrations.
6. *Participation in any aspect of the event is not confirmed until payment is made. Invoices will be sent by email following the entry deadline or when the event becomes full.*

SHOWMANSHIP SHOW

Saturday, April 11, 2026, 3:30 PM

Location: AG CENTER ARENA

Youth participants who have entered to show a steer or yearling heifer will be automatically entered in the Showmanship Show. Open to registered 4-H Club Members and Junior Exhibitors who are 9 to 21 years of age as of December 31, 2025.

1. Dry brush only
2. Entrants must show their own animal. Junior participants may have help in the ring from an intermediate or senior member.
3. Classes will be sub-divided following the registration if entries warrant.
4. Age classes will be split according to the number of entries received. Only the championship classes of each age division will be placed and receive prize money.
5. Class will be judged 100% on showmanship techniques.

CLASS 5

Junior Showmanship (9 years of age to 12 years of age as of Dec. 31, 2025).

CLASS 6

Intermediate Showmanship (13 years of age to 15 years of age as of Dec. 31, 2025).

CLASS 7

Senior Showmanship (16 years of age to 21 years of age as of Dec. 31, 2025).

RULES AND REGULATIONS

1. **ENTRIES CLOSE: March 20, 2026**
2. **FEES:** Entry fee of \$60.00 plus GST per animal (includes \$50.00 plus GST entry fee and \$10.00 plus GST environmental fee) paid at time of entry.
3. Open to registered 4-H Club Members and Junior Exhibitors who are 9 to 21 years of age as of December 31, 2025.
4. It will be the responsibility of the person who made the entry to advise the Saskatchewan Beef Expo Show Office of any cancellation of entries.
5. The Saskatchewan Beef Expo Committee reserves the right to cull any animal of inferior quality.
6. One heifer entry per exhibitor. Entry must be owned by a family member or be the exhibitors 4-H project.
7. The breed of the animal shall be determined by the **BREED OF SIRE** unless designated otherwise in the classification.
8. ALL ANIMALS MUST BE TAGGED WITH A RFID (CANADIAN CATTLE IDENTIFICATION ASSOCIATION) APPROVED EARTAG.
9. Open to both purebred and commercial animals of any recognized beef breed. Females will be judged as breeding animals.
10. Class #1 will be divided into individual breeds providing there are at least four animals entered of the same breed. Prize money will be paid for each breed class provided. If 12 or more entries per breed class are stabled, then the class will be split.
11. Animals are eligible for breed special awards by one breed only.
12. Animals must be stalled on the grounds by 11:30 am on Friday, April 10. Stalling available starting Thursday, April 9 at 3:00 pm.
13. Animals must be stalled at all times in designated areas only.
14. Stalling Space will be allocated to the number of animals that arrive.
15. **Release Time:** Following completion of the Steer Show, Sunday, April 12, 2026.
16. No adults will be allowed in the show ring.
17. We encourage parents to work with their children, not just do the work for them. Adults and *ATTENTION!* parents must keep in mind that this is an educational opportunity for the participants of the show and therefore limited parental involvement is encouraged.

HEIFER CLASSIFICATION

Class 1 **YEARLING HEIFER BORN JANUARY 1 – DECEMBER 31, 2025.**

Class 2 **GRAND CHAMPION & RESERVE GRAND CHAMPION YEARLING HEIFER**

Top two animals from all divisions of class 1 will compete.

Grand Champion Yearling Heifer Scholarship – the Grand Champion Yearling Heifer will receive a \$250.00 scholarship for education.

The scholarship prize money will be put towards the post-secondary education of the recipient's choice. Until claimed, the funds will be held in trust. In order for the funds to be released, Saskatoon Prairieland Park must be notified of confirmation of enrolment into a program at a post-secondary institute.

STEER SHOW

Sunday, April 12, 2026 – 30 minutes after completion of the Heifer Show

Location: AG CENTER ARENA

RULES AND REGULATIONS

1. **ENTRIES CLOSE: March 20, 2026**
2. **FEES:** Entry fee of \$60.00 plus GST per animal (includes \$50.00 plus GST entry fee and \$10.00 plus GST environmental fee) paid at time of entry.
3. Open to registered 4-H Club Members and Junior Exhibitors who are 9 to 21 years of age as of December 31, 2025.
4. It is the responsibility of the person who made the entry to advise the Saskatchewan Beef Expo Show Office of any cancellation of entries.
5. The Saskatchewan Beef Expo Committee reserves the right to cull any animal of inferior quality.
6. One steer entry per exhibitor. Entry must be owned by a family member or be the exhibitors 4-H project.
7. The breed of an animal shall be determined according to the BREED OF THE SIRE (or as stated in the classifications).
8. Animals must be de-horned; animals with horns are not permitted in this competition.
9. ALL ANIMALS MUST BE TAGGED WITH A RFID (CANADIAN CATTLE IDENTIFICATION ASSOCIATION) APPROVED EARTAG.
10. **Steers will be weighed starting at 5:30 pm Friday, April 10.**
11. Steers will be weighed only once.
12. Animals will be shown by weight. Classes will be split by weight; decided by the committee.
13. In each class, the top two (2) steers will be unplaced and both will be considered 1st place.
14. Top two (2) unplaced steers from each class will compete for the overall Grand Champion and Reserve Grand Champion.
15. Animals must be stalled on the grounds by 11:30 am on Friday, April 10. Stalling available starting Thursday, April 9 at 3:00 pm.
16. Animals must be stalled at all times in designated areas only.
17. Stabling Space will be allocated to the number of animals that arrive.
18. **Release Time:** Following completion of the Steer Show, Sunday, April 12, 2026.
19. We encourage parents to work with their children, not just do the work for them. Adults and *ATTENTION!* parents must keep in mind that this is an educational opportunity for the participants of the show and therefore limited parental involvement is encouraged.
